Install and use the Software on compatible devices

Use the Software for generating medical reports

Store and process data within the Software

You shall not:

Modify, adapt, or create derivative works of the Software

Reverse engineer, decompile, or disassemble the Software

Remove or alter any proprietary notices in the Software

Use the Software for purposes beyond intended medical report generation

Share your account credentials with others

Exceed your subscription tier's report limits

The Software collects and processes dictation data for report generation

Usage statistics for service improvement

Account information for authentication
